The mission of HD Faculty™ is to do that which it is in business to do, through the seeking of honour over wealth that leads to prosperity and honour!

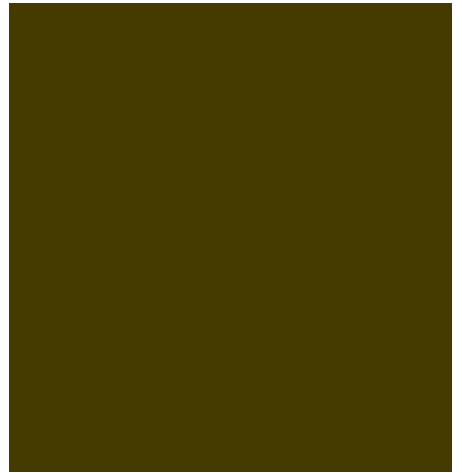

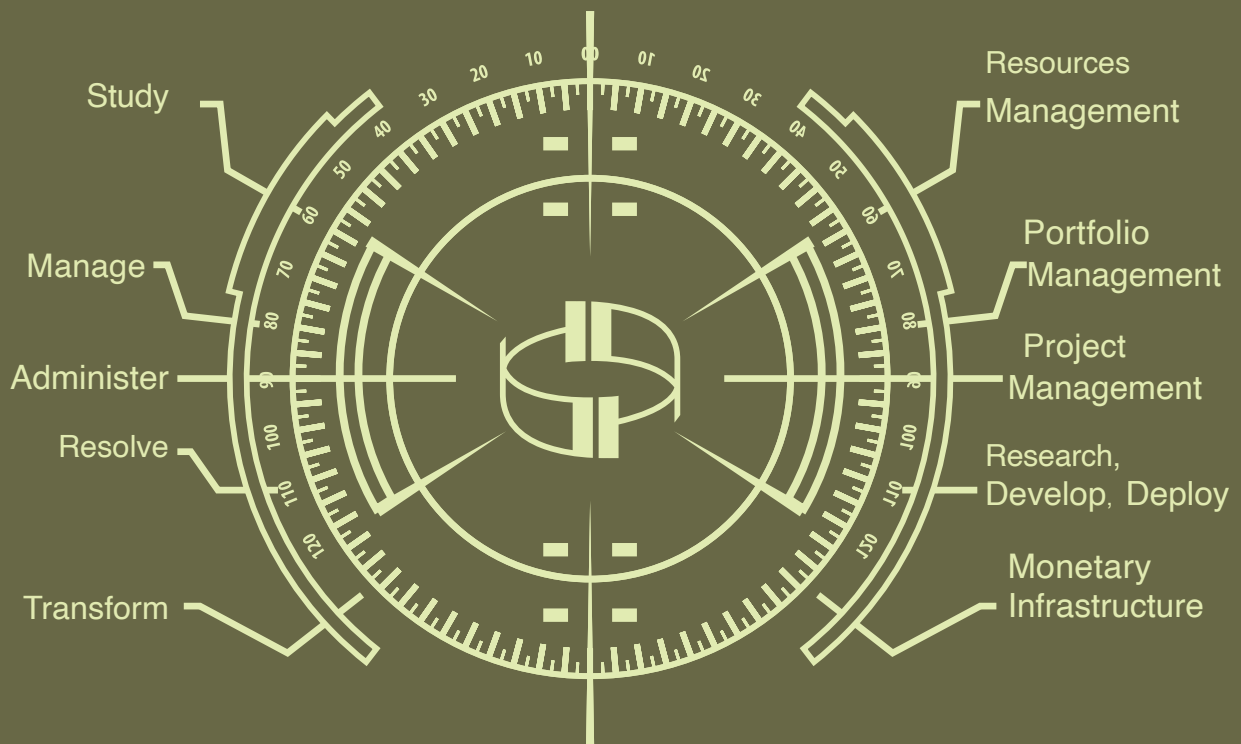

Where HD Faculty™ operates, it will:

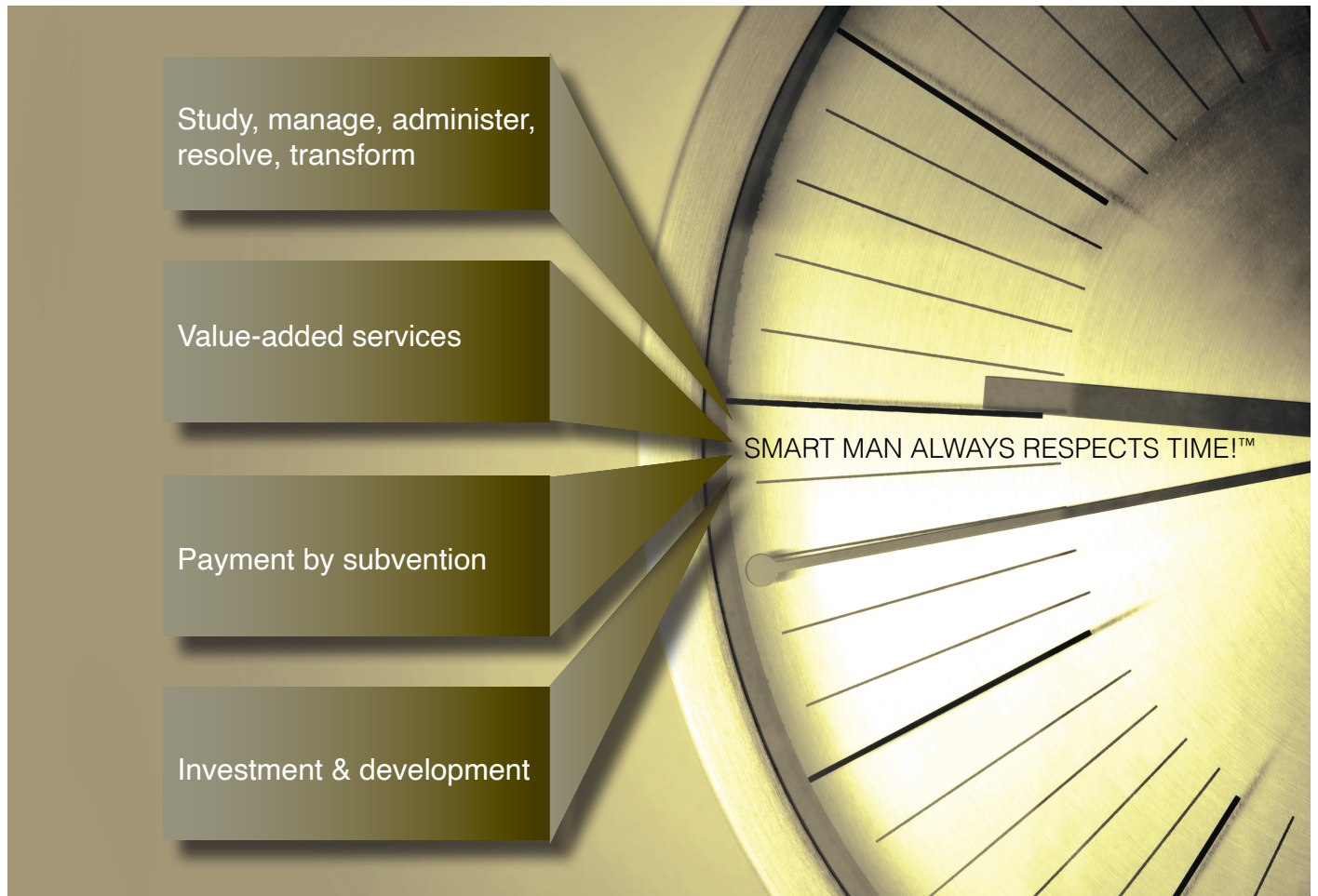
